1. 1776, 12 Apr. Whitehall. J. Pownall to John Robinson. Asks for Lord's Commissioners of the Treasury to order endorsed list of arms and accoutrements for the Corps of Royal Highland Emigrants serving in North America under Lt. Colonel Allan McLean. List not enclosed. 80.951.1
2. 1776, 7 Aug. Whitehall. William Knox to John Robinson. Lord George Germain considers as reasonable the enclosed memorial of Mr. Neilson, late Deputy Auditor and Deputy Naval Officer of North Carolina and asks the Lords Commissioners of the Treasury to consider it. Memorial is not enclosed. 80.952.1
3. 1778, 12 June. Whitehall. Lord George Germain to the Lords Commissioners of the Treasury. Refers to the recommendation by Governor Martin of Capt. Alexander MacLean of 11th Regiment who had settled in North Carolina. He is a loyalist who has served the Government well and is now indigent in England and solicits competency for his support. 80.953.1
4. 1778, 16 June. Whitehall. Thos. de Grey, jr. to John Robinson. Transmits memorial of Capt. MacLean and refers to above letter of 12 June. 80.954.1
5. 1778, 11 Dec. Whitehall. Lord George Germain to Lords Commissioners of the Treasury. Gen. Clinton is to invade Georgia and establish contact with loyalists in North and South Carolina. Lord George requests the Treasury to direct that provisions for 5000 men be sent to Georgia. 80.955.1
6. 1779, 6 March. Whitehall. Thos. de Grey, jr. to John Robinson. He is directed by Lord George Germain to send the enclosed memorial of Martin Howard, Chief Justice of North Carolina, to be laid before the Lords Commissioners of the Treasury. The memorial is not enclosed. 80.956.1

1. 1781, 7 July. Whitehall. Lord George Germain to Lords Commissioners of the Treasury. Encloses memorial from Governor Martin stating his losses during the Rebellion while serving as Governor of North Carolina. Lord George asks that the memorial be considered by the Lords Commissioners of the Treasury. The Memorial is not enclosed. 80.959.1
2. 1781, 23 July. Whitehall. W. Knox to Sir Grey Cooper. Discussion of Governor Tryon's accounts from New York. He mentions compensation for Tryon's extraordinary expenses in North Carolina, estimated at about £7000. £2000 was paid to him from the King's Civil List and an additional salary of £1000 a year was to have been charged upon the American revenue. Problems have arisen from the failure of that revenue and the disruption of governor's fees, prerequisites of office and Provincial allowances. 80.960.1-2
3. 1781, 19 Oct. Whitehall. Lord George Germain to Lords Commissioners of the Treasury. Concerns provisions for troops in America and mentions supplies for men in South Carolina, North Carolina, Georgia and East Florida. 80.961.1-3
4. 1782, 15 March. Whitehall. J. Fisher to Sir Grey Cooper. Transmits petition of Samuel Marshall, late of North Carolina, and asks Sir Grey to lay it before the Lords Commissioners of the Treasury. 80.962.1

1. 1782, 15 March. "Memorial and Petition of Archibald and John Hamilton, late of North Carolina, Merchants." Assert that they are Loyalists, persecuted and forced to flee in June, 1777, leaving property worth £180,000. They located a debtor, David Olphiant, at Charlestown and sought redress by law, but Lt. Col. Balfour freed him in hopes of formulating a general exchange of prisoners. They seek a grant to replace this loss and to sustain their families until they can regain property. A postscript by Dunmore, dated 15 March, 1782 at Charlestown, attests to the truth of their petition.
