This volume was the result of a resolution (N.C. Acts, 1826-27, p.85) passed by the General Assembly of North Carolina, Febuary 9, 1827. This resolution proposed that the Governor of North Carolina apply to the British government for permission to secure copies of documents relating to the Colonial history of North Carolina. This application was submitted through the United States Minister to the Court of St. James, Albert Gallatin. Gallatin was given permission to secure copies of documents relating to the Colonial history of North Carolina.

Gallatin found documents in the Board of Trade Office and the "State Paper Office" (which was the common depository for the archives of the Home,

Foreign, and Colonial departments) and made a list of them.

Gallatin's list and letters from the Secretary of the Board of Trade and the Foreign Office were sent to Governor H.G. Burton, August 25, 1827 and

then were bound together to form this volume.

A lottery to raise funds for the copying of the documents was authorized but failed. The only result seems to have been for the State to have published, An Index to Colonial Documents Relative to North Carolina, 1843. During the period, 1906-1908 the Historical Commission secured permission from Lord Dartmouth, through the agency of the firm B.F. Stevens and Brown, London, to have copied such private papers of Lord Dartmouth, Secretary of State for the Colonies in 1772, as related to North Carolina.

This copying was done and 63 manuscripts were bound into one volume during the period 1912-1914. Also in this collection is a transcript copy of the North Carolina Gazette. April 20, 1775, and a facsimile of the Olive Branch Petition, 8 July 1775 (both unbound).

In 1926 D.L. Corbitt, Calendar Clerk of the North Carolina Historical Commission, prepared a calendar of the Dartmouth Manuscripts which was published by the Commission in Calendars of Manuscript Collections, Vol. 1, 1926, pp. 1-11. This volume may be consulted in the Search Room for a more detailed listing of the manuscripts in this collection.

The civil administration of the navy began with King John who appointed a "Keeper of the King's Ships". During the reign of Henry VIII the navy was placed in charge of a separate department. The Navy Office was founded on April 24, 1546. During the middle of the sixteenth century the Admiralty was separated into three distinct parts: the Lord High Admiralty, later the Admiralty Board, exercising executive and diliberative functions; the Navy Board, exercising civil and administrative functions; and the High Court of Admiralty, exercising judicial functions. From 1689-1782 the admiralty system consisted of an Admiralty Board, a Navy Board, and a series of lesser boards and offices.

The directive branch of the Admiralty shaped the policy of the government, generally under the direction of the King, by orders from the Privy Council or by orders from the Secretary of State. It controlled the movement of ships, corresponded with admirals, vice-admirals, captains, commanders, and lieutenants of squadrons, and after 1762 kept elaborate digests of letters from them. It made appointments and signed warrents, administered the oath and test to naval officers, granted protection from impress, furnished passes to merchant vessels, kept in touch with subordinate officers, watched over the Greenwitch Hospital, received reports from subordinate boards and in turn drafted memorials and resolutions to the Privy Council and Treasury. It authorized all issues of money for the upkeep of thenavy and payment of all personnel, civilian and military. It was in close touch with the High Court of Admiralty and issued letters of marque, controlled the holdings of courtmartials, and had immediate supervision of the marines.

The Secretary: Department of the Admiralty Board contains the correspondence, minutes of the Admiralty Board and miscellaneous items.

The Medical Board was organized during the period of the Commonwealth but was permanently established in 1740 to take care of sick and wounded seamen, superintend the medical stores supplied by the apothecary general for use by the navy, manage naval hospitals ashore and afloat, examine and appoint naval surgeons, and maintain and exchange prisoners of war. The board attended the Admiralty whenever requested and took its orders only from the highest authority. The records of this department consists of packets of letters from surgeons and agents of the sick and wounded seamen, requests for food and medicine, reports of the Medical Board and hospital reports.

The Registered Seamans Act required all mariners to contribute sixpence a month from their wages to support the Greenwitch Hospital. This was extended to the colonies. Receivers were appointed at each port and the Collectors of Customs were to deduct the amount from the wages of the merchant marine.

Henry Hulton was the principal Deputy Receiver of the sixpence duty in the American colonies.

Volumes in this series contain accounts of receipts and collections made at the different ports. There are also the in-letters and out-letters dealing with the various accounts.

This series of Admiralty Papers contains transcripts from the Secretary Department, Medical Department, and the Greenwitch Hospital. The volume number and dates assigned by the British Public Record Office are given before each description of the contents.

This series of records is divided into two parts, the Declared Accounts and the American Loyalist Claims. The Declared Accounts contains accounts of Governor Josiah Martin of North Carolina and also an account of the duties arising under the Stamp Act.

The Audit Office settled accounts declared before them for the government and followed practices which appear to have originated during the sixteenth century. The Audit Office prepared two copies of a particular account, one on paper and the other on parchment. Both copies were then sent to the Treasury Office. After the two copies were approved and signed the paper copy was returned to the Audit Office where it was kept. The various deputies in the American colonies were required to declare their accounts.

The American Loyalist Claims were the results of an attempt made in the years, 1783-1803, to carry out the terms of the 6th Article of the Treaty of Paris. Loyalist were paid various pensions and compinsations for losses. They were paid for debts due to confiscation, professional services rendered, and matters of like nature. A Board of Commissioners was authorized to investigate the claims.

The records of the Audit Office are larger and more important than the Treasury Office claims. These records consist of declarations and reports in volumes and bundles. The volumes are the entry books and ledgers containing the memorials, evidence of witnesses, the testimonials, the decisions of the board and the allowances allowed. The bundles consist of the original memorials, certificates, accounts and vouchers of the various claimants as presented to the Commission. The Audit Office claims were divided into two classes, 12 and 13. Those claims which related to North Carolina were copied for the Historical Commission.

The Colonial Office Papers are those papers that came into the hands of the various commissions, committees and councils of trade and plantations before 1696; and, secondly, the American and West Indies and Board of Trade Papers, including Board of Trade, Commercial", which began generally around 1689-1690. The Colonial Papers and Entry Books probably represent the accumulations of the Secretary of State, the Privy Council and various bodies that had to do with the Plantations after 1660. The American and West Indies Papers are composed of original documents which came into the hands of the Secretary of State for the southern department until 1768 and of the Secretary of State for the colonies after that date. They are, therefore, Colonial state papers.

The greater number of documents, other than military, contained in these volumes (No. 1-150), were sent by the colonial governors to the Secretary of State. The royal governors were required to correspond with the Secretary whenever occurences happened within their government that demanded the immediate direction of the crown, or whenever special letters requiring answers were sent by the Secretary to the governor. It should be kept in mind that letters written the same day to different correspondents are quite disimilar in some cases. Letters to the Secretary furnish information on military affairs and matters of policy were never sent to the Board of Trade.

The letters are generally accompanied by enclosures, the dates of which are frequently earlier than the listed dates on each volume. These enclosures consist of printed broadsides, copies of proclamations, newspaper clippings, printed acts, manuscript copies of orders and resolves of the assembly, proceedings of council, assembly and council in assembly, bills, accounts, letters sent to governors, journals, diaries, petitions, and papers relating to religious affairs, trade, smuggling, the Indians and justice. The military correspondence and the entry books are of even greater value than the papers of the governors. The entry books usually contain copies of five classes of documents; letters, reports and representations, governors commissions and instructions, and abstracts and drafts of letters.

The second part of the American and West Indies apers are largely bundles containing papers that must have accumulated gradually in the hands of the secretary. The earliest of these are clearly papers of the Lords of Trade or Board of Trade. They consist of petitions and memorials, charges and counter-charges, affadavits and dispositions, complaints and appeals concerning colonial quarrels and disputes that had to be settled by a higher committee than the Privy Council or Board of Trade. Some of these papers probably came from the Privy Council office and a larger portion from the Secretary of State.

The collection of foreign state papers now in the British Public Record Office consists of such papers as had accumulated in the State Paper Office from earliest times and such other papers as were transferred to that depository from the Foreign Office between 1858-1862.

Though the term "Foreign Office" did not come into use for many years after 1782, the official classification of the papers has entered those of a date earlier than 1782 as State Papers, Foreign, and those of 1782 and later as Foreign Office Papers.

This series contains petitions and papers from the American series of the Foreign Office. The series consists of bundles of petitions presenting American claims. Some are from British officials and officers formally serving in America; others from Loyalist or from agents employed by them; while others are from persons having other claims against the government. These letters and petitions were sent to the Secretary of State and in many cases supplement previous petitions. In a number of cases they contain protests against the allowances of the American Loyalist Claims Commission. To the student of the Loyalist the documents are very important, supplementing the material found in the Audit and Treasury Series.

On warrants issued to the master of the Jewel House or Office by the Lord Chamberlain, orders were given to the goldsmiths to make silver communion plate for use in the chapels and churches of the colonies. When completed, such plate was received from the goldsmiths into the Jewel House and a receipt given therefor. From the Jewel House it was handed over to the governor of the colony or to someone authorized to receive it, and transmitted to North America. It was generally on loan to the governor for the use of the chapel or church in the colony, designed to be handed on from governor to governor, or, on demand, or when no longer needed, returned to the Jewel House. In all such cases the plate remained the property of the Crown. The plate consisted of two flagons, one chalice, one or two patens, and a receiver or basin.

The Treasury office had its beginnings during the days of the Normans. The office was in charge of a Treasurer and there was a distinct court of exchequer, which was the court in session dealing with questions of finance. The office was divided into the judicial and administrative branches. During the fourteenth century the head was the Kings Treasurer responsible for the revenue due and the smooth workings of the Exchequer machinery. He was the financial servant of the King until after the Revolution of 1688. In 1612 the office of Lord High Treasurer was put in commission and the Exchequer proper, which was the department of account and receipt, was separated from the Treasurer and the lords appointed by the King which constituted the department of financial control. Under Charles II the modern treasury, system came into operation. The Treasury Board sat in two capacities, executive and administrative, and continued to exercise these functions throughout the colonial period.

In its executive capacity the board considered westions of finances, debts, loans, petitions, requests, approvals, appointments, etc. Its activities in these fields gave rise to the minute books and the original correspondence. In its administrative capacity the board kept a series of books, in which were entered the warrants or orders by means of which expenditures were controlled.

The correspondence of the Treasury department includes the Privy Council, the Secretary of State, the Commissioners of the Customs, the Admiralty, colonian agents and a miscellaneous body of correspondents in America, etc. The board made up elaborate reports and sent them to Parliament, the Privy Council and the Board of Trade and it took into consideration any matters refered to it from one or the other of these bodies. It received a great many petitions, memorials, and proposals from the colonies on its own account.

The nucleus of the war office was the Office of Secretary at War which had its beginnings during the days of Cromwell. The duties of the secretary concerned the army wherever it might be. He had to raise levies and fill up the regiments with new recruits. He had to quarter and billet the soldiers. He drew up estimates for the army and moved that they be accepted by the House of Commons. He commissioned officers and authorized appointments. The duties of the secretary expanded rapidly during the war period from 1754-1783. Records also were increasing. Dispatches were sent and received from the colonial governors and Commanders-in-chief in America.

The majority of War Office Papers are of a date later than 1732, the earlier papers being scattered among those of the Secretary of State, the Admiralty, and the Treasury. There are letters from the earlier secretaries among the State Papers, Domestic and the Admiralty Papers.

The material in this series comes from the In-Letters, Headquarters Returns, Amherst's Papers and the Printed Lists divisions of the War Office Papers. The In-Letters are letters and enclosures from officers in America to the Secretary at War. The Headquarters Returns are those from America for the period from 1775-to 1778. The Amherst's Papers comprise 260 volumes. They relate largely to Amherst's posts as Commander-in-Chief of the British forces in America, 1758-1763. They include order books, reports, monthly returns and commissions. The Printed Lists are those issued annually for the army showing the officers and enlisted men of the different troops, regiments, independent companies, etc.
