This collection consists of records relating to the work of James C. (Jimmy) Green as special assistant to Governor Martin during the period of 1987-1991. Former lieutenant governor and long-time democratic politician, Green lost the Democratic primary in 1984 and threw his support to the Republican candidate James G. Martin. In 1985, Governor Martin appointed him as "Special Consultant on Legislation." After questions concerning Green's job description were raised by State Auditor Edward Renfrow in 1987, Green's job description and contract were rewritten to include additional responsibilities. As "Executive Advisor to the Governor," Green was appointed to several commissions, as well as the Governor's liaison to the State Department of Community Colleges. While facing two lawsuits regarding the destruction of his tobacco warehouse in Tennessee, Jimmy Green resigned his position with Governor Martin's administration in late 1991.
