Introduction

Scope of the Guide

This collection guide discusses the lives, labor, and experiences of enslaved persons in eighteenth and nineteenth century North Carolina, as documented in the Treasurer's and Comptroller's Papers. One of the largest collections of state agency records at the State Archives of North Carolina, the Treasurer's and Comptroller's Papers contain financial records from the colonial and antebellum eras, with records dating as early as 1682. Many records in this collection record the names and lives of enslaved persons, although the records position these individuals as property rather than as citizens. The Treasurer's and Comptroller's Papers provide a holistic view of North Carolina's early economy, including how the institution of slavery interacted with the economy at various levels. The documents listed in this guide depict those interactions, with enslaved persons appearing in various contexts throughout the collection, through the discussion of their labor, the transatlantic and trans-American trafficking of enslaved persons through ports, the sale and purchase of enslaved persons as property, and enslaved persons' interactions with early legal systems.

This collection guide focuses on three series in the Treasurer's and Comptroller's Papers:

- Capital Buildings
- Lands, Estates, Boundaries, and Surveys
- Miscellaneous Group

Researchers are encouraged to explore other series not discussed in this guide, which can be accessed by request at the State Archives. Two series, the Ports series and the Capital Buildings series, are also accessible digitally through the North Carolina Digital Collections on the State Archives of North Carolina website. This guide is intended to highlight the records that contain the names and labor of enslaved persons and to encourage further research on the history of slavery in North Carolina.

Content Warning

Archival records reflect the language and attitudes of the historical period in which they were created. The Treasurer's and Comptroller's Papers include content and language that may be harmful or upsetting to researchers. These records include actions that can be offensive, discriminatory, and depict acts of violence. Researchers should be prepared to encounter upsetting and offensive terminology describing enslaved persons.



A Brief History of the Treasurer's and Comptroller's Papers

History of the State Treasurer

In the colonial era of North Carolina, the Office of the Treasurer consisted of one appointed Treasurer aided by six under treasurers and twelve auditors. In 1711, seven treasurers were appointed to serve the different geographical areas of the state. The General Assembly decided to dismiss the seven-treasurer system in 1784 in favor of a single State Treasurer who was elected by both the House of Commons and the Senate to serve a two-year term. North Carolina's state constitution of 1868 brought change to the office once again, increasing the term to four years and making the position a publicly elected one.

History of the State Comptroller

The General Assembly appointed the first Comptroller of the State of North Carolina in 1782. The Comptroller was responsible for directing the stating, checking, and controlling of public accounts and keeping these accounts for the General Assembly's inspection. Originally, ten boards of auditors worked under the Comptroller and were located in areas across the state. This system changed in 1862 when the Office of Auditor of Public Accounts was created, and again in 1868, when the state constitution made the position publicly elected by popular vote.

History of the Collection in the Archives

Many of the records in what is now the Treasurer's and Comptroller's Paper were first transferred around 1920 to 1922 to the North Carolina Historical Commission, the predecessor of the Office of Archives and History. In 1961, the Archives' staff began to arrange the papers of the Treasurer and Comptroller. When archivists found that the papers from both offices had become intermingled before being transferred to the Archives and that the types of records created by each office were very similar, a decision was made to combine the two groups of papers into one: the Treasurer's and Comptroller's Papers. Certain groups of records were also added to the Treasurer's and Comptroller's Papers due to their financial nature. These included the Miscellaneous Railroad Papers, the financial records in the War of the Revolution Papers, and the Customs House and Ports Records.

How to Read the Guide

This guide discusses the following three series in the Treasurer's and Comptroller's Papers record group, all of which contain documents recording the labor and lives of enslaved persons in North Carolina:



- Capital Buildings
- Lands, Estates, Boundaries, and Surveys
- Miscellaneous Group

The types of records found in each series are described further in the *Overview of Each Series* section. This collection guide has two tables, one focusing on broad subjects that may guide various research topics, with a second table focusing on the names of enslaved persons. Both tables contain records from all three series.

Table 1: Records by Subject Heading

This table indexes historical documents found in the Treasurer's and Comptroller's Papers that contain evidence of enslaved persons and their labor. This table is arranged by series, and then each document is arranged chronologically by date. Each document is tagged with subject headings to guide those researching a general history of slavery in North Carolina or who wish to research certain topics in connection to enslaved persons. Each document appears in a table like the one below:

- The **Item** column provides the title of the document. If the title is in quotation marks, then the words were transcribed directly from the document.
- The **Citation** column indicates how researchers can locate the document in the State Archives, either physically, digitally, or both. Some enslaved persons appear multiple times across different documents, some entries will include multiple citations to reflect this. A breakdown of the citation is below:



Receipt of Payment to E. Geddy for hire of Bob, Squire, and Charles → The title of the document. If the title is in quotation marks, then the words were taken directly from the document.

11 August 1821 → The date listed on the document itself.

Treasurer's and Comptroller's Papers → The record group that the item and series is located in. All records in this guide are from the Treasurer's and Comptroller's Papers.

SR.204.8.001 → The container ID. This number identifies which box or volume in which the document is located.

Folder: "State House: Hire of Enslaved Persons, 1821." → The title of the folder in which the document is located.

SR_204_8_TC_Capital_Buildings_Bx1_Fldr26 → The digital identifier. If a series has been digitized and made available on North Carolina Digital Collections, objects are assigned a unique digital identifier. Researchers may use this digital identifier in the search bar of Digital Collections to quickly locate the document they are searching for. In this guide, only the Capital Buildings series is digitally accessible, so only Capital Buildings entries have the digital identifier in the citation column.

- The **Date** column provides the date on the document itself. If no date was written on the record, the **Date** column is left blank.
- The **County** column provides the county that was recorded in the document. If there is no documentation of a county in the record, the **County** column is left blank. Researchers should note that historic county boundaries may differ from modern boundaries.
- The **Subject Headings** column provides subjects to better facilitate research. A list of headings can be found below along with their definitions.



Definition of Subject Headings

- Capital Projects: Construction projects pertaining to the building, maintenance, upkeep, and furnishing of state government buildings across North Carolina.
- Confiscated Property: The Confiscation Acts were passed by the North Carolina General Assembly from 1776 through the 1780s to confiscate the property of Loyalists. This was done to punish and control the Loyalists as well as to obtain income for the state. Most of the confiscated real estate was sold in 1786 and 1787 and netted North Carolina about £600,000. The confiscated land records in the Treasurer's and Comptroller's Papers detail property confiscated by the state during this time, which also includes enslaved persons as property.
- Freedom Seekers: Any individual that escaped from slavery before and during the American Civil War.
- Executions: Putting to death as a legal penalty. Documentation includes executions ordered by Magistrates and Freeholders Courts.
- **Families**: Enslaved families sometimes appear as family units and listed together for "hiring out," sale, or purchase by enslavers. You may find an enslaved woman listed with her children, or an enslaved husband and wife listed together in such documents.
- Hiring Out: The term "hiring out" refers to the systematic contracting of enslaved labor, where enslavers would contract out their
 enslaved laborers to others, rather than having them work on their own property. Any profits earned through this labor went to the
 enslaver.
- **Internal Improvements**: Refers to public works during the nineteenth century, typically the creation of transportation infrastructure such as roads, turnpikes, canals, and navigation improvements.
- Magistrates and Freeholders Court: These courts were special courts erected to try enslaved persons under provision of the following acts of the North Carolina General Assembly: 1715 NC c.66, s.11; 1720 NC c.5; 1741 NC c.24, s.46-55; and II 1764 NC c.8, s.3. The jurisdiction of the court extended to capital punishment and was final, although speedy exercise of a Writ of Certiorari could prevent execution of sentence until the trial had been reviewed by the district Superior Court. Magistrates and Freeholders Courts ceased when jurisdiction for trials of enslaved persons was transferred to the county Courts of Pleas and Quarter Sessions under the provisions of 1793 NC c.5. Jurisdiction was further altered when felonies extending to capital punishment and clergiable felonies were placed under the exclusive jurisdiction of the county Superior Courts by the acts 1816 NC c.14 and 1825 NC c.24.
- Sale of Enslaved Persons: The legal and financial transaction of trafficking enslaved persons from enslaver to enslaver. This includes discussions of both the private sale of enslaved persons and public auction. While the importation of enslaved persons became illegal in 1808 with the "Act Prohibiting the Importation of Slaves," domestic trafficking of enslaved persons remained legal in parts of the United States until the end of the Civil War.



Table 2: Enslaved Persons by Name

This table focuses on the names of enslaved persons found in the Treasurer's and Comptroller's and may be particularly useful for those conducting genealogical research or those researching the lives of individual enslaved persons or families. This table is arranged alphabetically by the name of the enslaved person; when identical names appear, they are listed chronologically. Each name appears in a table like the one below:

- The **Enslaved Person** column contains the name of an individual enslaved person. Sometimes, records show different spellings of names (i.e., Ceasar/Cesar); the name column includes these various spellings.
- The **Enslaver** column includes the name of the person(s) who enslaved the individual in the **Enslaved Person** column. In the Confiscated Lands records of the *Lands, Estates, Boundaries, and Surveys* series, former enslavers are sometimes mentioned alongside new enslavers. If there is no documentation of an enslaver's name in the record, the **Enslaver** column is left blank.
- The **Date** column lists the date on the document itself. If no date was written on the record, the **Date** column is left blank.
- The **County** column shows the county that was recorded in the document. If there is no documentation of a county in the record, the **County** column is left blank.


The **Citation** column indicates how researchers can locate the document in the State Archives, either physically, digitally, or both. Overview of Each Series


Capital Buildings (1767-1919)

The Capital Buildings series contains financial records relating to the construction, maintenance, and furnishing of state government buildings in North Carolina. The most common types of records in this series include pay warrants, payrolls, receipts, and accounts. Some of these records, particularly receipts of payment for repairs on the State House, document the names and labor of enslaved persons. Most frequently, enslaved persons are found within the context of the hiring out system, wherein enslavers would "hire out" an enslaved person to another individual and then receive compensation for the labor. Information about enslaved persons may include name, location, the name of the enslaver, the type of labor performed by the enslaved person, the length of time hired, and the amount paid to the enslaver. While some descriptions of enslaved labor in this series are vague, they often include the location of labor (i.e., "hire of Jim for work on the State House"). Other descriptions are more in-depth, with some enslaved persons being associated with a certain trade, like masonry or carpentry. As the records in this series do not follow a standardized format, there is little consistency across records. The Capital Buildings series can be accessed both physically and digitally with the series available online in the North Carolina Digital Collections. This series is arranged chronologically by building project.



This receipt pertains to the "hiring out" system, as documented in the Capital Buildings series. This document provides evidence of the labor of Samson, a man enslaved by Eleazer Colburn, in February and March of 1840. Receipt of payment to Eleazer Colburn for work of Samson, 1840, Treasurer's and Comptroller's Papers, SR.204.8.003, Folder: "State Capitol: Hire of Wagons, Teams, and Oxen."





This receipt also pertains to the "hiring out" system, as documented in the Capital Buildings series. This document records the labor of two enslaved men, Jeff and Jim, who worked on repairs for the State House in August 1821. Receipt of Payment to Rebecca E. Goodwin for Hire of Jeff and Jim for Repairs on the State House in August, September 1821, Treasurer's and Comptroller's Papers, SR.204.8.001, Folder: "State House: Hire of Enslaved Persons, 1821."

Lands, Estates, Boundaries, and Surveys (1752-1931)

The Lands, Estates, Boundaries, and Surveys series contains records concerning different land matters in North Carolina. These include the Boundary Line Papers, materials on confiscated lands, land entry receipts, settlements of estates, miscellaneous land records, and an account of public lands. The names of enslaved persons are found within the settlements of estates and the materials on lands and property confiscated from British loyalists. Most commonly, enslaved persons are listed alongside other confiscated land and chattel property. Information about enslaved persons may include name, sex, location, the name of the former enslaver, the amount the enslaved person was purchased for, and the name of the new enslaver. Like other series in the Treasurer's and Comptroller's Papers, the records in the Lands, Estates, Boundaries, and Surveys series do not follow a standardized format. This series is not currently available digitally but can be accessed physically by request at the State Archives of North Carolina. This series is arranged alphabetically by record type, and then arranged alphabetically or chronologically.

An account of sale of twenty-eight enslaved persons enslaved by Thomas Oldham upon his death, found in the *Lands, Estates, Boundaries, and Surveys* series. These enslaved persons were sold at a public auction in Edenton on June 22, 1782. This document records the name of the enslaved person, either listed as an individual or as part of a family unit, their new enslaver, and the amount paid by the new enslaver. *Treasurer's and Comptroller's Papers, SR.204.22.004, Folder: "Confiscated Property Other than Land, 1776-1786."*



Miscellaneous Group (1736-1912)

The Miscellaneous Group series contains many different types of records that may include mention of enslaved persons. Such documents include those pertaining to the estate sale of John Haywood and in a division of enslaved persons among Samuel Sutton's heirs. The most notable group of records in this series are those of the Magistrates and Freeholders Courts. The Magistrates and Freeholders Courts were special courts created to try enslaved persons under the provisions in several acts of the North Carolina General Assembly between 1715 and 1764. Magistrates and Freeholders Courts ceased when jurisdiction for trials of enslaved persons was transferred to the county Courts of Pleas and Quarter Sessions under the provisions of 1793 NC c.5. Punishments ranged from severe bodily harm to execution. If the court decided to execute an accused enslaved person, the enslaver could petition the North Carolina government for compensation. As enslaved persons were treated as property to be bought and sold, enslavers were able to receive payment for enslaved persons based on their proclaimed value, which was determined by the government. Types of documents mentioning enslaved persons in the Magistrates and Freeholders Courts records include receipts of payment to executioners, receipts of payment to enslaved persons of an executed enslaved person's value. Other information about enslaved persons may include name, sex, location, the name of the enslaver, the determined value of an enslaved person. The

Miscellaneous Group series does not follow a standardized format. This series is arranged alphabetically by subject and can be accessed by request at the State Archives of North Carolina.

A certificate documenting the execution of Essex, an enslaved man, in 1739 by the Court of Magistrates and Freeholders for Bertie County. In this document, Essex is noted to be valued at £200, for which the enslaver, Thomas Barker, received compensation.
